With this project, VDOT proposes to replace the Route 250 (Ivy Road) bridge over Little Ivy Creek. Two construction alternatives were presented at the public hearing. Which alternative do you support?

**Alternative A:** Full road closure with detour for two weeks. Eastbound motorists would be directed to Interstate 64 and use exit 118 to Route 29 (Monacan Trail) north, which carries traffic back to Route 250. Westbound motorists would reverse the detour and use exit 107. The detour from one end of the bridge to the other is approximately 24 miles. Local traffic may use alternative secondary routes to navigate around the closure.

**Alternative B:** Phased construction. The bridge would be reduced to one lane and two-way traffic would be controlled by temporary signals for at least three months. A significant disruption to traffic flow, especially during rush hour, is expected with this alternative.
