- Construct a diverging diamond interchange (DDI) on Route 250 and Interstate 64 at exit 124

- Replace the existing loop ramp from southbound Route 29 to eastbound I-64 with dual left-turn lanes and a connection to the existing ramp from northbound Route 29 to eastbound I-64

- Improve the Fontaine Avenue exit ramp from northbound Route 29

- Construct a roundabout at the intersection of Route 250 (Rockfish Gap Turnpike) and Route 151 (Critzlers Shop Road) near the Nelson County line

- Construct a 0.25-mile two-lane road to connect Rio Mills Road to Berkmar Drive Extended
