

Minutes of the Meeting of the State Highway
Commission of Virginia, Held in
Richmond, July 15th, 1939.

On the morning of July 15th, 1939, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wade E. Massie, Secretary, S. W. Rawls and J. F. Wyzar, met in their office, State Office Building, Richmond, Va.

The meeting was called to order by the Chairman.

Moved by Mr. Rawls, seconded by Mr. Wyzar, that the minutes of the meeting of May 25th be approved. Motion carried.

Miss Clara Smith, of Croxton, Va., appeared before the Commission concerning right of way through her property on Route 1 at Ladysmith, requesting the same value be paid for her property as paid the other property holders. No action was taken as the Commission had no recourse, the option having been fully complied with.

Hon. Junius E. West, of Suffolk, Va., appeared before the Commission concerning insurance on property in the eight construction districts, as well as the Equipment Depot and the new Highway Office Building, asking that he be given some of the insurance business of the Department.

Dr. A. L. Tynas, of Staunton, Va., appeared before the Commission concerning right of way on Route 260 through the property of the Beverley Manor Orchards, Inc., Augusta County, relative to certain definite verbal understanding, covering a triangle strip of land abutting his property and a proper outlet. The Commission and Dr. Tynas agreed on a settlement of \$108.50 for the track of land to be deeded to Beverley Manor Orchards, Inc., preserving certain water rights, dam and water line to other property.

Moved by Mr. Shirley, seconded by Mr. Rawls, that the request of the Isaac Walton League to deny the people the right to fish from Lynnhaven Bridge on Route 60, be turned down and fishing from the bridge permitted. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Rawls, that the request of Mr. W. A. Heine, Mayor of Boyce, Virginia, to have the location of Route 60 come through Boyce, rather than follow the Waterloo Route as adopted by the Commission, be not granted and Mr. Heine notified accordingly. Motion carried.

RESOLUTION AWARDEING CONTRACT

WHEREAS, Carneal, Johnston & Wright, Consulting Architects and Engineers, pursuant to a Resolution heretofore adopted, have tabulated and considered all bids heretofore received for the construction of air conditioning system for the Central Highway Office Building, and have duly made their recommendations to this Commission, and it appearing from said recommendations and report that Carbondale New York Co., Inc., New York, N.Y., is the lowest and best Bidder for the construction of the air conditioning system for the Central Highway Office Building, in the sum of \$109,565.00 and Special Provision -Awarded with option that Alternate Bid of \$31,400.00 may be accepted within thirty days; and that this Commission, after considering said report and recommendations of all bids heretofore filed, finds that the bid of Carbondale New York Co., Inc., is the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED BY THE State Highway Commission of Virginia, AS FOLLOWS:

Section 1. That the bid of Carbondale New York Co., Inc., for the construction of air conditioning system for the Central Highway Office Building, in the sum of \$100,000.00 and Special Provisions - Awarded with option that Alternate Bid of \$51,400.00 may be accepted within thirty days; is hereby accepted, determined and declared to be the lowest and best bid, however, this award shall not be effective until the awardee shall have been notified in writing by the Architects of the State Highway Commission of such award. That upon the awardee being so notified in writing a contract for the construction of said work, as heretofore prescribed by the plans, specifications and contract documents, shall be forthwith executed for said construction.

Moved by Mr. Rawls, seconded by Mr. Wymor, that the request of the various counties and citizens interested for the Commission to give a public hearing on the location of the proposed bridge across the Rappahannock River at or near Fredericksburg, be granted. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Massie, that the Chairman be authorized to try and work out with the Government the financing of the Bridges at Riverton on Route 3, generally as outlined in letter of July 11th to Mr. Thos. H. MacDonald, applying for a PWA grant. If such a grant cannot be secured that he proceed to work it out under Federal Aid. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Massie, that the Chairman be authorized to make an application for additional PWA grant for the overrun on the State Highway Office Building. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Rawls, that whereas past experience of the State Highway Commission in dispossessing any agency of Highway Department space temporarily occupied, has been sad and expensive; that space was curtailed and not assigned to it, constructed with Highway funds, and later was required to pay rent for such space; therefore be it resolved that no space of any kind in the new building being constructed exclusively for the Highway Department, be assigned to any other department of agency. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Rawls, that the request of Mr. Robert T. Barton, Jr., Richmond, Va., to take over plot of land and monument thereon commemorating a deed of valor by Lt. Col. Snowden Andrews, having been considered, the Commission feels this is a function of the State Conservation Commission and that the Highway Commission cannot enter into these functions. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that if Arlington County will move the bank building at Cherrydale on Route 211, Project 531, without expense to the Highway Department, the Commission will widen the road, if not to construct back of the bank if right of way can be secured. Motion carried.

Moved by Mr. Massie, seconded by Mr. Shirley, that the Department proceed with condemnation proceedings on Route 250, east of Nelson-Albemarle County line in Albemarle County and see what the costs will be before any construction is undertaken. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Massie, that the Commission eliminate from Article I, Section 2, of the rules and regulations covering outdoor advertising, and in place thereof turn this work over to the Engineering Department, under the Maintenance Engineer. Motion carried.

There being no further business the meeting adjourned, subject to call by the Commissioner.
