Find out about plans to construct missing segments in the bicycle and pedestrian network within two miles of the future Loudoun Gateway (Route 606) and Ashburn Metrorail stations. The planned improvements will occur along Shellhorn Road, Wynridge Drive/Claude Moore Avenue, Ashburn Village Boulevard, Waxpool Road, Smith Switch Road, Route 606, Prentice Drive, Pacific Boulevard and Loudoun County Parkway. The project also includes pedestrian improvements at the intersections of Ashburn Village Boulevard and Shellhorn Road, Farmwell Road and Ashburn Village Boulevard, and Farmwell Road and Smith Switch Road.

The public hearing will be held as a **virtual/online meeting**. Information for accessing and participating in the virtual meeting is available at **www.virginiadot.org/LoudounMetroBikePed**. The project team will make a short presentation beginning at 6:30 p.m. and answer questions for about an hour after the presentation.
