Dear Gentlemen:

Item 456 B.3 of Chapter 874 of the 2010 Acts of Assembly, requests that the Commonwealth Transportation Commissioner develop a report on the cash balances of the Route 58 Corridor Development Fund. The language specifically requested that the report include three items: (i) a comparison of actual spending to allocations by project and district; (ii) expenditures by project, district, and funding source, and (iii) a six-year plan for planned future expenditures from the Fund by project and district. In addition to the requirement of the legislation, the report also includes background information on the program relating to previous actions by the General Assembly and the Commonwealth Transportation Board.

Estimates and expenditures included in the attached report are shown as of April 30, 2010. The total expenditures were \$1.141 billion for the Route 58 Corridor Development Program. This includes \$415 million in the Bristol District, \$80 million in the Hampton Roads District, \$145 million in the Lynchburg District, \$247 million in the Richmond District, and \$254 million in the Salem District. ## U. S. ROUTE 58 CORRIDOR DEVELOPMENT PROGRAM

### Executive Summary

Item 456 B.3. of Chapter 874 of the 2010 Acts of the Assembly directs the Commonwealth Transportation Commissioner to report on the cash balances in the Route 58 Corridor Development Fund. The report shall include: (i) a comparison of actual spending to allocations by project and district, (ii) expenditures by project, district and funding sources and (iii) a six-year plan for planned future expenditures from the Fund by project and district.

Allocations and expenditures are shown as of April 30, 2010 based on the FY 2010-15 Six-Year Improvement Program (SYIP). Total expenditures were \$1.141 billion for the Route 58 Corridor Development Program. This includes \$415 million in Bristol District, \$80 million in Hampton Roads District, \$145 million in Lynchburg District, \$247 million in Richmond District, and \$254 million in Salem District.

# U. S. ROUTE 58 CORRIDOR DEVELOPMENT PROGRAM

## Program Background

- 1989 General Assembly Actions:
  - Authorized the U. S. Route 58 Corridor Development Fund and Program.
  - Authorized \$600 million in revenue bonds.
  - Designated first \$40 million of recordation tax revenues for program funding.
  
- 1999 General Assembly Actions:
  - Increased the debt authorization for the U. S. Route 58 Corridor Development Program by \$104.3 million.
  - Specified projects within the U. S. Route 58 Corridor Development Program to benefit from the increased debt authorization as follows:

- Ben Hur to Pennington Gap in Lee County	\$ 9.8 million
- Pennington Gap to Dryden in Lee County	\$ 35.6 million
- Anticipated shortfall on the Danville Bypass, Clarksville Bypass, Stuart Bypass, and Completion of a gap west of Jonesville in Lee County	\$ 35.1 million
- Taylors Valley in Washington County	\$ 1.5 million
- Right-of-Way Acquisition from the town of Stuart in Patrick County along the Route 58 Corridor to its intersection with Interstate 77 in Lee County	\$ <u>22.3 million</u>
Total	\$ <u>104.3 million</u>
  - The 1999 Appropriation Act included language which required the Secretary of Transportation and the Governor to propose funding to support debt service on the additional debt authorization.

## **U. S. ROUTE 58 CORRIDOR DEVELOPMENT PROGRAM**

### **Program Background (Continued)**

- Commonwealth Transportation Board Actions:
  - Issued \$200 million in transportation revenue bonds in December 1989.
  - Adopted U. S. Route 58 Corridor Economic Development Program in May 1992.
  - Issued \$98.7 million in transportation revenue bonds in June 1993.
  - Issued \$114.3 million in transportation revenue bonds in November 1996.
  - Issued \$204.9 million in transportation revenue bonds in November 1999.
  - Issued \$102.1 million in transportation revenue bonds in September 2001.

### **Program Expenditures and Balances**

- As of April 30, 2010, program expenditures were \$1.141 billion.
- U. S. Route 58 Corridor Development Fund Balance - \$23 million.
  - Fund balance designated for priority projects identified in the SYIP and debt service payment on the bonds. (Balance reflects transfers out to pay May 15, 2010 debt service to Route 58 Bondholders.)
- Series 2001B bond proceeds balance - \$799,000.
  - Amount held by Trustee designated for Taylor Valley project specified by the 1999 General Assembly.
- Designated Virginia Transportation Act of 2000 (VTA 2000) funding has been fully allocated to complete construction projects and priority projects previously identified.
  - \$113 million of VTA 2000 funds have been allocated. The VTA 2000 fund balance is \$8 million.

## U. S. ROUTE 58 CORRIDOR DEVELOPMENT PROGRAM

- Transportation Partnership Opportunity Fund (TPOF).
  - \$77 million of TPOF funds have been allocated to the Hillsville Bypass PPTA Project. This project is part of the Route 58 Development Program. The TPOF balance is \$29 million.
  
- 2010 General Assembly Actions:
  - Directs the Commonwealth Transportation Commissioner to report on or before July 1 of each year to the Chairmen of the House Appropriations and Senate Finance Committees on the cash balances in the Route 58 Corridor Development Fund.
  
  - In addition, the report shall include the following:
    - i) Comparison of actual spending to allocations by project and district;
      - Attachment A compares allocations by project and district as programmed in FY 10-15 SYIP to actual spending.
  
    - ii) Expenditures by project, district and funding sources since inception;
      - Attachment B provides expenditures by project, district and funding sources.
  
    - iii) Six-year plan for planned future expenditures from the Fund by project and district.
      - Attachment C includes active projects in FY 11-16 SYIP.

      - Funding sources include the U. S. Route 58 Corridor Development Fund, Series 2001B Bonds, Federal Highway Reimbursement Anticipation Notes (FRANs), Priority Transportation Fund (PTF), Highway Construction Primary System, TPOF and American Recovery and Reinvestment Act of 2009 (ARRA).
